

## Toronto Hydro-Electric System Limited has applied to change its electricity distribution rates effective January 1, 2025

Toronto Hydro-Electric System Limited has applied to the Ontario Energy Board to change its electricity distribution rates. If the application is approved as filed, a typical residential customer and a typical general service less than 50 kW customer of Toronto Hydro-Electric System Limited would see the following monthly increase:

Year	2025	2026	2027	2028	2029
<b>Residential (750 kWh)</b>	\$3.24	\$3.40	\$3.72	\$3.97	\$2.86
<b>General Service less than 50kW (2,000 kWh)</b>	\$14.18	\$9.24	\$9.61	\$10.67	\$7.29

Other customers, including businesses, will also be affected. It's important to review the application carefully to determine whether you may be affected by the proposed changes.

The application seeks to establish new rate riders to dispose of balances in regulatory deferral and variance accounts and establish four new accounts.

The application also requests approval of a custom scorecard and custom rate framework to set distribution rates effective for the period from January 1, 2026 to December 31, 2029.

### YOU SHOULD KNOW

There are three types of OEB hearings: oral, electronic and written. The applicant has applied for, and the OEB plans to proceed with, an oral hearing. If you think a different hearing type is needed, you can write to us to explain why.

During this hearing, we will hear questions and arguments from participants about this case. We will also hear questions and arguments from participants that have registered as Intervenors. After the hearing, we will decide whether to approve the application.
